#### **Monitoring Tropical Storm Claudette**

I'm keeping an eye on Tropical Storm Claudette, which is expected to bring heavy rain and strong winds to the Louisiana coast this weekend. It's important for Louisiana residents in the path of this storm to follow the advice of local officials, monitor local news, and prepare diligently. Be cautious of storm surge and flash flooding as this system moves inland and prepare to seek higher ground should flood waters rise to dangerous levels.

#### Standing Up for Louisiana's Energy Workers

A federal judge in Louisiana on Wednesday blocked the Biden Administration from illegally suspending new oil and gas leases on federal lands and waters, underscoring what we already know — President Biden doesn't have the authority to ban oil and gas leasing in the Gulf of Mexico.

President Biden's decision to ban new leasing has already done serious damage to the economic livelihoods of millions of American families, and I'm glad to see the ruling block the Biden Administration from continuing their anti-American-energy leasing ban. Energy made in America creates jobs, lowers the cost of gas and electricity for all hard-working families and small businesses, and helps America's allies across the world.

Additionally, these leases bring critical dollars for coastal restoration, flood protection, education and countless other important services in the states that support these activities. I also applaud Louisiana Attorney General Jeff Landry for filing this lawsuit and arguing on behalf of thousands of energy workers.

#### **Recognizing Louisiana Civil Air Patrol Members**

These cadets have worked tirelessly to improve their skills in aerospace, leadership, physical fitness, and character development, and I couldn't be prouder of their achievements.

## Protecting U.S. Telecom Networks Against Chinese National Security Threats

I introduced the Secure Equipment Act of 2021 to prohibit the Federal Communications Commission (FCC) from reviewing or issuing new equipment licenses to companies on the FCC's "Covered Equipment or Services List" that pose a national security threat.

For far too long, we've allowed manufacturers like Huawei and ZTE, which are backed by the Chinese Communist Party, to have access to American networks. This has allowed our national security to be jeopardized and threatened the individual safety of the American people.

## **Weather Preparedness For Survivors In FEMA Temporary Housing Units**

Hurricane season has started and the safety and well-being of occupants living in FEMA temporary housing units is an important concern of the agency. Below are tips for preparing for hurricane related weather.

What to do During Severe Weather:

- If severe weather is predicted, stay alert to weather warnings and comply with any local official evacuation orders.
- Use the weather radio to monitor evacuation orders. Evacuate immediately if local officials recommend manufactured housing occupants find sturdier shelter.
- Should local officials recommend manufactured housing occupants find sturdier shelter, evacuate immediately. Survivors in travel trailers must leave the trailer in place.
- Never take shelter in a travel trailer or manufactured housing unit during high winds, tornadoes, hurricanes or floods.
   Expectations for FEMA Temporary Hous-

ing Occupants Before, During and After Severe Weather

Occupants in FEMA temporary housing units are not to board up windows, move the unit, or alter the units in any physical way. Individuals are only required to evacuate with their personal belongings when instructed to do so by state and local emergency management officials.

- FEMA strongly encourages applicants to get renters insurance while they are in FEMA units.
- Applicants in FEMA temporary housing units should develop their own evacuation and emergency communication plans.
- Occupants in FEMA temporary housing units should always follow the instructions given for evacuation by the state or local emergency management officials. Those who do not have the ability to evacuate can contact their local emergency manager or call 211 to help them with their transportation needs.
- Do not leave your pet behind in a manufactured housing unit or travel trailer during severe weather.
- If an occupant's unit is damaged, they are encouraged to contact their case worker to advise whether the occupant can return home, or they may call the FEMA Helpline at 800-621-3362. If you use TTY, call 800-462-7585. Those who

use a relay service such as a videophone, InnoCaption or CapTel should update FEMA with their specific number assigned to that service. The tollfree telephone lines operate from 7 a.m. to 10 p.m. seven days a week.

### Marilyn Cecilia Dufour Piattoly





## What should I bring to my vaccination appointment?

- A photo ID (passport, driver's license, etc.) and your insurance card, if available.
- There is no cost to the patient, and no one will be turned away based on their insurance status.

- Appointments across Ochsner Health clinics and community sites are available daily.
